The parties agree to negotiate in good faith to resolve any concerns raised as a result of renovations or remodeling and to enter into such amendments of this agreement as may be necessary to reasonably accommodate both parties' interests.

**ACCEPTANCE**

Country Inn & Suites Elk Grove Village/Itasca agrees to reserve the contracted guest rooms to the exclusion of other business opportunities. Should FSTNR Week 2022 cancel or reduce any contracted guest rooms after contracted August 7, 2022 date, FSTNR Week 2022 agrees to pay, as liquidated damages and not as penalty, a cancellation fee equal to 0 percent of total unreserved contracted guest room revenue based on the group rate.

Unless the Hotel otherwise notifies FSTNR Week 2022 at any time prior to FSTNR Week 2022's execution of this document, the outlined format and dates will be held by the Hotel for FSTNR Week 2022 on a first-option basis until **June 29, 2022**. If FSTNR Week 2022 cannot make a commitment prior to that date, the quoted arrangements are subject to change or, at the Hotel's option, the arrangements will be released, in which case neither party will have any further obligations. Only upon signature of this document by all parties will this document constitute a binding agreement. Upon signature by both parties, FSTNR Week 2022 and the Hotel shall have agreed to and executed this Agreement by their authorized representatives as of the dates indicated below.
